

CONTEST RULES
(the “Official Rules”)

Rogers Contest – Beyond the Seat Toronto Blue Jays™
(the “Contest”)

These Official Rules govern the Contest. By participating or attempting to participate in the Contest, you will be deemed to have read, understood, and agreed to be bound by these Official Rules.

1. WHO IS THE SPONSOR?

The Contest is sponsored and administered by Rogers Communications Inc. or one of its subsidiaries or affiliates (“**Rogers**”).

The Contest is in no way sponsored, endorsed or administered by, or associated with Rogers Blue Jays Baseball Partnership (“**RBJBP**”), owner of the *Toronto Blue Jays*™ Major League Baseball team (the “**Team**”), Rogers Centre Limited Partnership (“**RSLP**”), owner of *Rogers Centre*™ stadium (the “**Stadium**”), the Office of the Commissioner of Baseball (“**BOC**”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. (“**MLBAM**”), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (the “**Clubs**”), any of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, or the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities (the foregoing MLB entities, collectively, the “**MLB Entities**”) and each of them is completely released of all liability by each entrant in this Contest. Any questions, comments or complaints regarding the Contest must be directed to Rogers and not to RBJBP, RSLP and/or the MLB Entities.

This Contest is in no way sponsored, endorsed, administered by or associated with any third-party social media or social networking service or site (each a “**Third Party Service**”), including but not limited to Facebook, Instagram and/or X (formerly known as Twitter). Any questions, comments or complaints regarding the Contest should be directed to Rogers and not to any Third-Party Service.

2. WHO IS ELIGIBLE TO ENTER?

To be eligible to enter this Contest, an individual must:

- be a resident of Canada who has reached the age of majority in their province or territory of residence as of the date of entry; and
- be legally able to travel and possess all necessary documentation as may be required to claim and participate in a trip prize.

Employees, officers, directors, agents, and representatives of Rogers, RBJBP, the Team, RSLP, the Stadium, the MLB Entities, or any of their respective parents, subsidiaries, affiliates, prize suppliers, or advertising or promotional agencies, and members of the immediate family (spouse, parent, child, sibling) or household of any such individuals, whether related or not, are not eligible to enter.

3. WHEN DOES THE CONTEST START/END?

3.1 Contest Period

The Contest begins at 4:00 p.m. Eastern Time (“ET”) on Thursday, March 26, 2026, and ends at 11:59 p.m. ET on Sunday, September 27, 2026 (the “Contest Period”).

The Contest Period is divided into three (3) Tiers, with each Tier having its own schedule and prizes as follows:

3.2 TIER 1 - Winning Inning during select Toronto Blue Jays™ Games

Tier 1 consists of Winning Innings occurring during select Toronto Blue Jay regular-season games (each, a “Game”) during the Contest Period. Selection of each Game is at Rogers’ sole discretion. One (1) Winning Inning per Game.

3.3 TIER 2 - Beyond the Seat Secondary Prizes

Tier 2 consists of eight (8) entry periods each, a “Secondary Prize Entry Period”, in accordance with the following **Secondary Prize Schedule**:

Any eligible entries not selected during a given Secondary Prize Entry Period will carry forward into subsequent applicable Secondary Prize Entry Periods, in accordance with this schedule.

3.4 TIER 3 - Beyond the Seat Trip Prizes

Tier 3 consists of five (5) entry periods, each, a “Trip Prize Entry Period” in accordance with the following **Trip Prize Schedule**:

Any eligible entries not selected during a given Trip Prize Entry Period will carry forward into subsequent applicable Trip Prize Entry Periods, in accordance with this schedule.

4. HOW DO I ENTER THE CONTEST?

No purchase is necessary to enter the Contest. Enter using any of the methods of entry outlined below. No entries will be accepted by any other means.

For the purpose of this Contest, a “Rogers customer” is a consumer customer (i) who uses or subscribes to a Rogers postpaid consumer mobile plan (including wireless home phone and tablet data plan) or any Rogers or Shaw internet, TV, home phone, home monitoring or satellite plan; and (ii) whose Rogers account is in good standing and active or (i) whose Rogers mobile number is active.

4.1 TIER 1 - HOW TO ENTER

There is a limit of one (1) Winning Inning Entry (as defined below) per person per Game.

(i) ROGERS CUSTOMERS

Watch the broadcast of *Toronto Blue Jays* games on Sportsnet during the Contest Period to learn whether a Winning Inning will occur during the broadcast and for the cue to text. When a Winning Inning is confirmed during a Game, and if a *Toronto Blue Jay* player records a hit in that Game and a keyword appears onscreen, text the keyword to the short code displayed onscreen within the specified entry window to earn one (1) entry for that Winning Inning.

(ii) NON-ROGERS CUSTOMERS

Watch the broadcast of *Toronto Blue Jays* games on Sportsnet during the Contest Period to learn whether a Winning Inning will occur during the broadcast. When a Winning Inning is confirmed during a Game, and if a *Toronto Blue Jay* player records a hit in that Game and a keyword appears onscreen, send the keyword by email to info@rogersbtsbluejays.com within the specified entry window to earn one (1) Winning Inning Entry.

Each entry earned during a Winning Inning, as described above, is defined as a “**Winning Inning Entry**”.

4.2 TIER 2 AND TIER 3 - HOW TO ENTER

There is a limit of one (1) Initial Entry (defined below) plus five (5) Bonus Entries (defined below) per person/email address, regardless of method of entry, during the Contest Period

(i) ROGERS CUSTOMERS INITIAL ONLINE ENTRY & BONUS ENTRIES

- **Initial Online Entry:** During the Contest Period, visit www.rogers.com/bluejays and access the online entry form (“**Online Entry Form**”). Complete and submit the Online Entry Form as instructed to earn one (1) entry (an “**Online Entry**”) in each of the Secondary and Trip Prize Entry Periods as applicable, based on the date the Online Entry is submitted.
- **Bonus Entries:** To earn five (5) bonus entries in each of the Secondary and Trip Prize Entry Periods as applicable, based on the date the Online Entry is submitted, opt-in to receive marketing communications from Rogers Communications Inc. and affiliates via the Online Entry Form or send via mail during the Contest Period, a 75-word essay on “*your favourite Toronto Blue Jays memory*” along with your name, home address, day and evening telephone numbers, email address, and age, to the attention of Rogers Partnerships “**Rogers Contest– Beyond the Seat Toronto Blue Jays**” at 333 Bloor Street East, 5th Floor, Toronto, Ontario, M4W 1G9 (a “**Customer Bonus Mail-In Entry**”). To be valid, Customer Bonus Mail-in Entries must be received within the Contest Period.

(ii) NON-ROGERS CUSTOMERS INITIAL MAIL-IN ENTRY & BONUS ENTRIES

- During the Contest Period, send a seventy-five (75)-word essay via mail on “*your favourite baseball memory*” along with your name, home address, day and evening telephone numbers, email address, and age, to the attention of Rogers Partnerships “**Rogers Contest – Beyond the Seat Toronto Blue Jays**” at 333 Bloor Street East, 5th Floor, Toronto, Ontario, M4W 1G9 (a-“**Non-Customer Initial Mail-In Entry**”).

To be valid, Non-Customer Initial Mail-In Entries must be received within the Contest Period. Each valid Mail-In Entry will count as one (1) entry in each of the Secondary and Trip Prize Entry Periods as applicable, based on the date the Mail-in Entry is received..

- **Bonus Entries:** To earn five (5) bonus entries in each of the Secondary and Trip Prize Entry Periods as applicable, include and answer the following question at the end of your essay: *Who is your favourite Toronto Blue Jays player?* (a “**Non-Customer Bonus Mail-In Entry**”).

(iii) DEFINED TERMS

- Online Entries and Non-Customer Initial Mail-In Entries are collectively referred to as “**Initial Entries**”.
- Customer Bonus Mail-In Entries and Non-Customer Bonus Mail-In Entries are collectively referred to as “**Bonus Entries**”.
- Initial Entries and Bonus Entries are hereinafter collectively referred to as “**Entries**”.

4.3 Carry-Forward of Non-Selected Winning Inning Entries

Non-selected Winning Inning Entries in a given draw (refer to Section 10 below) will be carried forward and treated as one (1) eligible Entry in the upcoming Secondary Prize Entry Period and as one (1) eligible Entry in the upcoming Trip Prize Entry Period, subject to a maximum of one (1) Winning Inning Entry per person being carried forward during the entire Contest Period.

5. HOW MANY TIMES MAY I ENTER THE CONTEST?

5.1 Winning Inning Entries (Tier 1)

There is a limit of one (1) Winning Inning Entry per person per Game.

5.2 Initial Entries and Bonus Entries (Tier 2 & Tier 3)

There is a limit of one (1) Initial Entry plus five (5) Bonus Entries per person/email address, regardless of method of entry, during the Contest Period.

By way of illustration, if two (2) or more otherwise eligible entrants share a single email address, only one (1) of them may enter the Contest using that email address. If an eligible entrant has multiple email addresses, they may only enter the Contest once in respect of one (1) email address.

6. COULD MY ENTRY BE REFUSED OR REJECTED?

Entries may be subject to verification by Rogers at any time. Your entry could be refused or rejected if:

- a) you attempt to enter the Contest in a fashion not authorized by these Official Rules;
- b) your entry contains false or misleading information, or is late, falsified, illegible, damaged or

- incomplete or otherwise irregular;
- c) your entry is submitted using robotic, automated, programmed, or other illicit means; or
- d) your entry is not in compliance with these Official Rules.

Rogers reserves the right to refuse any entry for any other reason as they may determine.

7. WHAT ARE THE CONDITIONS OF ENTRY?

By entering the Contest:

- a) you agree to be bound by these Official Rules and by the decisions of Rogers, which decisions are final, binding and conclusive;
- b) you represent and warrant that: (i) your Entry, including any material comprising your Entry (e.g. name, user name, profile picture, voice recording, etc., as applicable) and any material submitted with your Entry (e.g. photograph, video, written submission, or other form of submission, as applicable) (all such material, collectively, the “**Entry Material**”) is original to you, (ii) you have all necessary rights in and to your Entry Material to enter the Contest, including the consent of any third parties whose personal information is included in your Entry Material, and (iii) your Entry Material does not contain, depict, include or involve content that is, or could reasonably be considered to be, inappropriate, unsuitable or offensive, as determined by Rogers;
- c) you understand and agree that your Entry, including your Entry Material, will not be returned to you and may be moderated or edited by Rogers as it deems appropriate;
- d) you grant to Rogers, RBJBP, and MLBAM the irrevocable right to use your Entry Material in any media worldwide and for any purpose related to the Contest (or any similar contest), including the right to use, reproduce, modify, adapt, translate, or create derivative works from, your Entry Material without notification, compensation or additional consideration to you;
- e) you waive all claims of moral rights in any use of your Entry Material by Rogers pursuant to the rights granted in these Official Rules; and
- f) you release, waive and forever discharge Rogers, RBJBP, the Team, RSLP, the Stadium, the other MLB Entities, and each of their respective parents, affiliates, and subsidiaries, any other companies associated with the Contest, and all of their respective directors, officers, employees (including Team players), agents, representatives, licensees, successors and assigns, as well as any Third Party Services, (collectively, the “**Releasees**”), and agree to indemnify and hold harmless each of the Releasees, from and against any and all claims, damages or liability, including any costs or losses related to personal injury, death, damage to or loss or destruction of property, arising out of, or in any way related to, (i) your participation in the Contest, (ii) the awarding, receipt, possession, use or misuse of any prize, in whole or in part, including participating in travel or any activity related to the prize, (iii) the use of any Entry Material or Publicity Material (defined below) in accordance with the rights granted in these Official Rules, or (iv) any breach of these Official Rules.

8. WHAT ARE THE CONTEST PRIZES?

Entrants may win multiple prizes, but no more than one (1) prize within each prize group. For instance, an entrant may win one (1) collectible merchandise item and one (1) jersey in Tier 1, as well as one (1) prize in Tier 2 and/or Tier 3.

8.1 Tier 1 - Winning Inning Prizes

There are up to **five hundred eleven (511)** Winning Inning prizes available to be won in the Contest as follows:

- i. five hundred (500) *Toronto Blue Jays* 50th Season collectible merchandise items (assorted, with a value ranging between \$25 and \$100);

- ii. ten (10) autographed George Springer jerseys (approximate value of \$500);
- iii. one (1) VIP trip prize to MLB All-Star Week 2026 having an approximate total retail value of four thousand dollars (CAD \$4,000) each and including:
 - Round-trip economy air transportation for the winner and one (1) guest (collectively, “**Travellers**”) from the international airport within Canada closest to the winner’s residence (as determined by Rogers) to Philadelphia, United States on travel dates to be determined by Rogers;
 - One (1) hotel rooms (standard room, based on double occupancy) for two (2) nights in or around Philadelphia, United States at a hotel to be selected by Rogers;
 - Tickets to the T-Mobile Home Run Derby;
 - Tickets to the MLB All-Star Game;
 - Tickets to Capital One All-Star Village; and
 - Transportation to/from the All-Star Game to the hotel.

Each VIP Trip Prize is valued at approximately four thousand dollars (CDN \$4,000)

8.2 Tier 2 - Beyond the Seat Secondary Prizes

There are up to **sixty-nine (69) Beyond the Seat Secondary Prizes** available to be won in the Contest, each having an approximate retail value of CDN \$400 and consisting of:

- two (2) admission tickets to attend a *Toronto Blue Jays* 2026 regular-season home game at on a date determined by Rogers in its sole discretion. Tickets are planned for the Rogers Beyond the Seat area but location may vary at Rogers’ sole discretion.

8.3 Tier 3 - Beyond the Seat Trip Prizes

There are five (5) Beyond the Seat Trip Prizes available to be won in the Contest as follows:

- i. four (4) *Toronto Blue Jays* 2026 regular-season home game trip prizes, having an approximate total retail value of three thousand five hundred (CAD \$3,500) each and including:
 - Round-trip economy air transportation (subject to paragraph 8.5 (i) below) for the winner and one (1) guest (collectively, “**Travellers**”) from the airport within Canada closest to the winner’s residence (as determined by Rogers) to Toronto on travel dates to be determined by Rogers;
 - One (1) hotel room (standard room, double occupancy) for two (2) nights at the Toronto Marriott City Centre Hotel (Rogers Centre), on dates determined by Rogers in its sole discretion; and
 - Two (2) admission tickets to attend a *Toronto Blue Jays* 2026 regular-season home game at Rogers Centre in Toronto on a game date in accordance with the applicable Trip Prize Entry Period. Tickets are planned for the Rogers Beyond the Seat area but location may vary at Rogers’ sole discretion.
- ii. one (1) VIP trip prize to MLB All-Star Week 2026 having an approximate total retail value of four thousand dollars (CAD \$4,000), including:
 - Round-trip economy air transportation for the winner and one (1) guest (collectively, “**Travellers**”) from the international airport within Canada closest to the winner’s residence (as determined by Rogers) to Philadelphia, United States on travel dates to be determined by Rogers;
 - One (1) hotel rooms (standard room, based on double occupancy) for two (2) nights in or around Philadelphia, United States at a hotel to be selected by Rogers;
 - Tickets to the T-Mobile Home Run Derby;
 - Tickets to the MLB All-Star Game;
 - Tickets to Capital One All-Star Village
 - Transportation to/from the All-Star Game to the hotel.

8.4 Terms and conditions applicable to tickets awarded in this Contest:

- i. Any and all additional costs and expenses associated with the acceptance and use of the tickets including but not limited to, transportation to and from any game location, and not expressly specified herein as being provided are the sole responsibility of the winner and/or their guest(s).
- ii. Rogers and prize suppliers have the right to disqualify or remove any winners or guests from any activity at any time without compensation or substitution if they are at any point uncooperative, disruptive, abusive, unobservant of applicable rules, laws, or regulations, or likely to cause or has caused damage to person, property, or the reputation of Rogers or prize suppliers.
- iii. Use of any Major League Baseball game/event/exhibition ticket is subject to standard terms, conditions, and health and safety policies applicable to the ticket; see <https://www.mlb.com/all-star/tickets/terms-and-conditions> or www.bluejays.com/ticketterms for details, depending on the prize. Major League Baseball game, event and exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club, as applicable, and may be subject to change. The terms and conditions of the tickets awarded as part of the prize will govern in the event a legal game, event or exhibition, as defined by Major League Baseball, is not played or held, as applicable, due to weather conditions, an act of God, an act of terrorism, civil disturbance or any other reason. The winner and their guests agree to comply with all applicable stadium and venue, as applicable, regulations in connection with the prize; see www.bluejays.com/ticketterms for details. The applicable MLB Entities reserve the right to remove or to deny entry to the winner and/or guest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at any Major League Baseball game, event or exhibition. The Releasees (defined below) will not be responsible for acts of God, acts of terrorism, civil disturbances, work stoppages, epidemic, pandemic, natural disaster, or any other issue concerning public health or safety, or any other event outside their control that may cause the cancellation or postponement of any Major League Baseball game, event or exhibition. Major League Baseball game, event and exhibition tickets awarded as part of the prize may not be resold or offered for resale or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the licence granted by the game, event or exhibition tickets.
- iv. No responsibility is assumed by the Releasees for any other factor beyond its reasonable control, or for canceled, delayed, or re-scheduled concerts for any reason whatsoever.
- v. Due to the nature of the prizing, no alternate game dates are available.

8.5 Terms and conditions applicable to the *Toronto Blue Jays* 2026 regular-season home game trip prizes and the VIP trip prizes (collectively “trip prizes”) awarded in this Contest:

- i. If the winner of a *Toronto Blue Jays* 2026 regular-season home game trip prizes resides within 150 kilometres of Rogers Centre, as determined by Rogers in its sole discretion, air transportation will not be awarded, and the Travellers will be solely responsible for all costs of transportation (and no additional compensation or substitution will be awarded for any difference in prize value).
- ii. The winners may be required to reserve the trip prize, or complete travel, by a particular date, as advised by Rogers. The trip prize is not eligible for frequent flyer miles. All bookings and/or reservations are subject to availability at the time of booking. Once reservations are made, they cannot be changed, unless otherwise determined by Rogers or prize suppliers.
- iii. Travellers must have reached the age of majority in his or her province or territory of residence, unless accompanied by a parent or legal guardian.
- iv. Travellers may be required to present a valid major credit card upon check-in at the destination to cover any expenses above and beyond the standard room charge.
- v. If the winner elects to travel with a fewer number of guests than the number of guests provided in the prize description above, no additional compensation will be awarded under any circumstances.
- vi. Tickets are subject to certain terms and conditions as specified by issuers. Blackout dates may apply.

- vii. The Travellers are responsible for: transportation to and from originating airport; transportation to and from Destination airport; travel and medical insurance; travel documentation; any and all applicable taxes; and any additional expenses not included in the prize.
- viii. The Releasees are not responsible for any cancellations, alterations, delays, diversions or other changes to the trip itinerary, any costs or expenses incurred as a result of any changes to the trip itinerary, or any damages, loss or liability in the event any Travellers is denied the ability to travel, whether due to airport restrictions or otherwise.
- ix. Rogers has the right to disqualify or remove any Traveller from any activity at any time if they are at any point uncooperative, disruptive, abusive, unobservant of applicable rules, laws or regulations, or likely to cause or has caused damage to person, property, or the reputation of Rogers or the Team.

9. ARE THERE ANY PRIZE CONDITIONS?

All prize particulars will be determined by Rogers in its sole discretion. In addition to any prize conditions provided elsewhere in these Official Rules, any prize awarded in the Contest is subject to the following conditions:

- a) The prize value stated in these Official Rules is approximate only. A winner will not be compensated if the actual prize value is lower than the value quoted in these Official Rules;
- b) Rogers reserves the right, in its sole discretion, to substitute a prize, in whole or in part, with a prize or prize component of equal or greater value if a prize or any component thereof cannot be awarded for any reason;
- c) The prize must be accepted as awarded and may not be resold, be transferred, commercially traded, assigned, or redeemed for cash unless otherwise determined by Rogers. The prize may not be exactly as advertised and is provided “as is” without representation or warranty of any kind;
- d) Any unused portion of the prize, including Trip Prizes, once awarded, will be deemed forfeited. A prize will not be replaced if lost, destroyed, mutilated or stolen or in the case of a Trip Prize, will not be replaced if not taken for any reason.

10. HOW WILL THE POTENTIAL WINNER(S) BE SELECTED?

10.1 TIER 1 - Winning Inning Draws

At the end of each Game (as defined above in Section 3), Rogers will conduct a random draw from all eligible entries received for the corresponding Winning Inning. Entrants will be randomly selected as a potential winner and notified using the information provided at the time of entry.

The number and the selection of Winning Inning Prizes awarded in any Winning Inning draw will be determined by Rogers in its sole discretion.

In the event a potential winner does not respond to the notification within the specified timeframe, declines a prize for any reason, or does not meet the requirements set forth in these Official Rules, as determined by the Sponsors in their sole discretion, the potential winner will be disqualified and, time permitting, an alternate potential winner may be randomly selected from among remaining eligible entries.

10.2 TIER 2 AND TIER 3 - Secondary Prizes and Trip Prizes

In accordance with the dates and times noted in the Schedules in Section 3 above, Rogers will conduct random draws at **333 Bloor Street East, Toronto, Ontario**, from all eligible Entries received during each applicable Entry Period.

Each potential winner will be notified using the contact information provided at the time of entry. Eligible Entries that are not selected in a given draw will carry forward into any subsequent applicable Entry Period.

In the event a potential winner does not respond within **one (1) business day** of notification, declines a prize for any reason, or does not meet the eligibility or verification requirements set out in these Official Rules, as determined by Rogers in its sole discretion, the potential winner will be disqualified and, time permitting, an alternate potential winner may be randomly selected from among the remaining eligible Entries.

10.3 If, as a result of an error relating to the entry process, drawing, or any other aspect of the Contest, there are more selected entrants than contemplated in these Official Rules, there will be a random draw among all eligible prize claimants following the end of the Contest Period to award the correct number of prizes.

11. HOW CAN A POTENTIAL WINNER BECOME A WINNER?

Before being declared a winner, a potential winner must:

- a) correctly answer, without assistance, a time-limited mathematical skill-testing question to be administered by Rogers;
- b) be in compliance with these Official Rules;
- c) sign and return, within any designated time period, a release of liability and consent to publicity form (the "Release Form") and any other documentation as reasonably required. Rogers may require a winner's guest to sign and return a Release Form and other documentation as a pre-condition to participation. If any guest is a minor, the parent or legal guardian must sign on their behalf; and
